The regular advertised Workshop Meeting of the Borough of Robesonia Council was held on Monday, October 20, 2025 at the Robesonia Borough Hall located at 75 S. Brooke Street Robesonia, PA. The following Council members attended:

The meeting was called to order at 7:02 PM.

New Business:

- A motion was made by Michael Martin to approve Resolution 2025-6 which appoints Ann Reynolds as Interim Tax Collector and Kloma Kalbach as Interim Deputy Tax Collector. Seconded by Matthew Miller. Motion carried.
- Council reviewed multiple social media posts which included Parks & Recreation Board member Beth Sattizahn advising individuals to boycott food trucks at the Borough Car Show. The Car Show was held as a fundraiser by Parks & Recreation to raise funds for the playground replacement project. After a lengthy discussion, a motion was made by Matthew Miller to approve Resolution 2025-7 which censures Parks & Recreation Board Member Beth Sattizahn. Seconded by Michael Martin. Mark Spotts and David Bright voted nay. Motion carried.
- Solicitor Andrew George advised Council that the Borough never passed an official resolution establishing the Parks & Recreation Board. A motion was made by Matthew Miller to temporarily disband the Parks & Recreation Board until Council passes a resolution to officially establish it. Borough Council will oversee current events that have been planned by the Board. Seconded by Michael Martin. Motion carried.
- A motion was made by Mark Spotts for the Borough to advertise for part-time snow plow drivers. Seconded by Michael Martin. Motion carried.
- Council had a discussion regarding the Grande environmental remediation project. A memo was presented to Council from Jen McConnell, Borough Engineer. Mark Spotts made a motion that the Borough should indicate that they want to be a part of the public meeting. The Borough should also state that Jen McConnell will be representing the Borough and should respond stating such. Seconded by Jame Burrus. Motion carried.

Public Comment

Beth Sattizahn: Beth Sattizahn read a statement to Council regarding her censure resolution. Beth asked for a copy of the evidence Council was provided with and the resolution. Solicitor Andrew George stated she should fill out a Right to Know Request.

Tracy Rice inquired on the status of the structural engineer report the Borough is waiting for.

Dave Fegley stated his disappointment in Council.

Cindy Mordough encouraged the Borough to post all ordinances online.
