- Grande was notified by the Borough Engineer that Robesonia Borough would like to comment on their remediation project.

#### Council Member Reports

- Mayor:
  - Rodney Soliday thanked the residents and Council for the opportunity to serve on Council and as Mayor.
- Marshall:
  - A motion was made by Mark Spotts to transfer remaining funds from the trash account at Fulton Bank to PLIGIT and then close the trash account. Harvey Marshall explained that the trash account is no longer needed due to trash being added to the tax bill. Seconded by Michael Martin. Motion carried.
- Martin:
  - Michael Martin expressed his appreciation to the Borough Council for the opportunity to serve during his tenure on the Board.
- Spotts:
  - After a discussion, a motion was made by Mark Spotts for the Borough to enter into a contract with No Nonsense Neutering. The Borough will pay all expenses for up to 24 cats per year, at \$40 per cat, for a total annual cost not to exceed \$960. Seconded by David Bright. Jame Burrus voted nay. Motion carried.
