- A motion was made by Matthew Miller to accept M&A Excavating LLC's \$6,800.00 proposal to repair an inlet and pipe repair on Freeman Street & Furnace Road. Seconded by Jame Burrus. Motion carried.
- The Council had a discussion regarding what the Borough could reach out to Reading-Berks Auto Club Foundations Opportunity. This item will be back on the agenda next month under old business.

 Avenue in the Borough, more residents from the Borough should express their desire for one and possibly start
 a petition.
